The motion carried unanimously. Ayes: O'Connell, Broderick, Mahalik, Morales, and Wunderlich. Student Trustee Marin favored the motion.

8.1 J.D. Ross ESA Award

Trustee Mahalik moved, seconded by Trustee O'Connell that the Board of Trustees of Joliet Junior College approve the recipients of the J. D. Ross Extraordinary Service Award. Trustee Broderick commented that this is a nice award to receive for our community members. Trustee Broderick indicated that we need to make sure that our instructions are clear so that the person doing the nomination fully understands why they are submitting this individual for this award. This would be a submission of the true qualifications for this person for this award. Trustee Broderick stated that she looked at the information the Board received and would like to know who we are supporting, not just the one or two chosen. When she first came on the Board, they were given the degree of information that was needed to know who the candidates were for this award. Trustee Broderick asked if we can obtain this information as she does not feel comfortable giving a blanket vote and who the people are that are being supported by the nominees. Trustee Broderick also would like to see if we need to improve the system to get better information to the people who are nominating these individuals for this award. This would insure that people do get recognized properly instead of saying there is not enough information on this nominee so let's go to the ones that do have this information. Trustee Broderick stated that she knows some of the people that were submitted, but that there was not enough information to do bring them forward for the award. Chairman Wunderlich stated that in order to keep the names confidential prior to the awards ceremony, the Board will ask for approval for each candidate separately. The Board has the names of candidate one and candidate two in front of them. Candidate One Roll Call: Ayes: Mahalik, Morales, O'Connell and Wunderlich. Nays: Broderick. Student Trustee favored the motion. Trustee Morales moved seconded by Trustee O'Connell that the Board of Trustees approve Candidate Two for the J. D. Ross Extraordinary Service Award. Ayes: Morales, Broderick, Mahalik and Wunderlich. Nay: O'Connell. Student Trustee Marin favored the motion.

6.0 Board Business Trustee Broderick commented that she noticed that Northern Illinois University has an expedited two-year nursing program if they come in with an AS degree. Trustee Broderick asked if that was something that we can look into. President Mitchell indicated that we can look into this, but we will need to get additional information as we are a two-year college and we would need to make sure that this is permissible. Trustee Broderick would like administration to further study this because NIU is a state college and it is a two-year accelerated degree and feels that we should be able to offer this as well and is challenging President Mitchell on this request. President Mitchell stated that we will look into this request, but as you know we have attempted to get permission from the ICCB to permit community colleges to offer the BSN degree.

Trustee Morales indicated that she had been asked if there was any way Joliet Junior College could open a CADC degree, which is an advanced degree for social workers.

There is a strong need for this with the opioid epidemic that we are facing in Will County. Our residents are going to the College of Dupage for this degree and Trustee Morales would like to see JJC offer the degree. Chairman Wunderlich commented that the University of St. Francis offers this degree, Certified Alcohol Drug Counselor, and requires a Bachelor's Degree to practice in this field. Lewis University had one but this degree was not accredited. Trustee Morales stated that she will let these individuals know that unfortunately, JJC will not be able to offer this as it is a four-year degree.

7. & 8. There were first and second board policy readings in the packet.

9.1 Foundation Report Trustee Garcia is not present this evening; however, Ms. Mulvey will give the Foundation Report to the Board. Ms. Mulvey gave the following report: Happy New Year! I'd like to announce this year's Night of Stars recipients: Susan H. Wood Award – Peter Neff and Alumni Achievement – William Conte. This year we have a new award, the Corporate Partners in Excellence Award – LyondellBasell. The Night of Stars will take place on Thursday, April 23 at 5 p.m. at the Renaissance Center. Invitations will be sent in the coming months. All Spring 2020 scholarships were placed on student accounts before classes started this Monday. Fall scholarships will be posted on February 1, and will remain open until May 1. Recently, we lost three JJC retirees, all of which have endowed scholarships with the JJC Foundation: Richard Manthei, John Corradetti, and Curtis Egglike. This year's year-end giving has increased 81% from 2018. We were lucky to secure several gifts, including two endowments from JJC alumni Jim Harder and Paul Gantzert. This year's JJC Sock Campaign will take place from February 3 – February 21. Socks can be purchased at www.jjc.edu/jjcsocks.

9.2 ICCTA Report Trustee Broderick indicated that she would like to see JJC host the regional meeting for the ICCTA group that includes South Suburban, Kankakee, Prairie State, Moraine Valley and JJC. Trustee Broderick would like to see the meeting happen after the March primary elections and would like to find a few dates. The meeting would be at 6 p.m. We had a good attendance last year, but she would like to see additional attendance. We have a few issues that are in play now, such as the marijuana and the minimum wage increase. They are looking at JJC because of our accelerated IT area. Trustee Broderick thanked Jim Serr for his leadership role in this huge IT undertaking. Perhaps we can invite the winners of the primary election to the meeting as well, so they can better understand our needs. The National Legislative Summit is in Washington, DC from February 9 – 12 and if any board members have monies in their budget and would like to attend you are encouraged to do so. Trustee Broderick, Student Trustee Marin, President Mitchell and Kelly Rohder Tonelli will be in attendance. We are working with ACCT/ICCTA to get more information to our Board members on legislative issues as they come up and to try to get more board involvement at the national and state levels.

9.3 Student Student Trustee Marin indicated that her report will be brief this evening as classes have just begun for this semester. Today and tomorrow we are holding welcome week to help get students back into the swing of classes. The passport to success is later in the week which encourages students to attend various events on campus. The hope is that as students attend these events they will be motivated to join clubs and get involved at JJC. If the student attends 20 different events, their name is entered into a raffle drawing for a \$250 visa gift card. We want our students to do more than go to school here and to feel like this is a place to connect and relax with other students and the college community. Student Trustee Marin commented that she appreciated being a speaker at the general session event, which was nerve-racking. Trustee Broderick stated that she listened to Student Trustee Marin's speech and she did an amazing job. Student Trustee Marin indicated that she is happy that people still like to hear her story and commented that

Aaron Wyncott also did a great job with his speech. They both came out of adult education and had a similar journey. Student Trustee Marin thanked the faculty for their kind comments and for their great teaching,

9.4 Buildings &

Trustee Mahalik indicated that the committee met before the meeting tonight. QBS: Architectural & Engineering Services Master Plan: Bid was advertised on November 14; 362 vendors were notified with 23 responses; an optional pre-bid meeting on 11/21-32 vendors attended; these services are included within the \$13.9M master plan budget. The evaluation committee selected nine firms as potential finalists. These nine firms were invited on campus the week of January 20th to provide more information about their project teams approach to managing construction cost, and project deliverables. An architect can qualify for all of the projects or one project. One architect was chosen to compete for two projects and the other eight are only eligible to compete for one of the four projects. We are trying to pick the right architect for each project, as if they were stand-alone. The selection is based on the qualifications of the firm first, and then fees for services will be negotiated before contracting. Project Status Report - Replace Elevators J & G Buildings which is a CDB Project; and upcoming bids were also reviewed.
