4.3.1 Ellucian Colleague	Dr. Namuo gave an overview of the ERP restart including proposing two project managers. One for HCM/Finance and one for the SIS (Student Information System) both of which will report to Dr. Farmer. Dr. Namuo proposed to stay with Ellucian Colleague for another two years (2023 – 2025). JJC will also execute the suggestions CampusWorks provided includin creating a new governance structure. JJC will have a new budget for the restart which will come from reserves. JJC will appoint a Trustee as a liaison to receive regular updates. JJC w continue to engage CampusWorks over the life of the project. Trustee Broderick thanked Dr Namuo and Dr. Farmer for their open approach and leadership regarding Workday. Trustee				

Morales said she wanted everyone to know that the board has been listening and also thanked Dr. Namuo and Dr. Farmer. Dr. Namuo acknowledged that there will be challenges moving forward but he is committed to transparency and open communication on a regular basis.

Trustee Morales moved, seconded by Trustee Mahalik to approve the Ellucian Colleague renewal of annual software maintenance agreements for two more years. Ayes: Broderick, Budzinski, Mahalik, Morales, and O'Connell. Student Trustee Stamborski favored the motion. The motion carried.

4.4 Approval of New Women's Sport (Women's Wrestling) Roberto C. Valadez said that funding for this sport will come via a donation from the Foundation. Greg Braun, Director of Athletics, said that female wrestling is just booming in the JJC area. Also, the softball team is ranked number eight in the country. Women's track and field, which is in their first year, is ranked number three in the country. Men's track and field, also in their first year in existence, is ranked number ten in the country. Trustee Morales asked if JJC's sports are highlighted when recruiting at the high school level. Mr. Braun said athletics are currently working with marketing on this issue. JJC will be the pioneers in having a female wrestling team. Trustee Budzinski suggested JJC should host a female high school wrestling tournament to promote that JJC has this sport.

Trustee Morales moved, seconded by Student Trustee Stamborski to approve adding Women's Wrestling as a sport. Ayes: Broderick, Budzinski, Mahalik, Morales, and O'Connell. Student Trustee Stamborski favored the motion. The motion carried.

4.5 Agenda Request By a Trustee There was no agenda requests from any trustee.

Reports

5.1 President's Report President Namuo congratulated all the retirees and thanked all those that ran for the board. He congratulated trustee elects Alicia Morales and Diane Harris and thanked those that will be stepping away, Dan O'Connell and Student Trustee Joshua Stamborski. He welcomed the incoming Student Trustee Iyeisha Ellis. Dr. Namuo said he participate in the new CEO Academy at the American Association of Community College Annual conference in Denver, CO. He acknowledged the Will County Heroes Scholarship Program which will launch a \$10 million scholarship program to boost teaching and nursing recruitment. The President's cabinet had a retreat at City Hall in Morris with Dr. Lynn Tincher-Ladner who is an expert in community college stigma. Dr. Namuo acknowledged that the Governor's budget has an increase of 7% for higher education. He also gave a shout out to those third shift JJC employees.

5.2 Foundation

Kristi Mulvey from the Foundation said to mark your calendars for the JJC Foundation & Athletic golf outing on July 14. The JJC employee giving campaign has raised \$85,801 from 245 employees. The Night of Stars event will be coupled with the Foundation's 50th Anniversary celebration on September 15 at the Rialto. The annual JJC sock campaign raised \$5,500 selling 401 pairs of socks. This money goes to alumni scholarships.

5.3 ICCTA Reports

Chairman O'Connell introduced Trustee Broderick for the ICCTA report. Trustee Broderick informed the board that May 3rd is lobby day in Springfield. June 2nd and 3rd is the ICCTA annual convention in Bloomington where she will be sworn in as President of the ICCTA. On August 18th & 19th, the executive committee retreat will be at JJC. October 9th - October 12th is the ACCT Leadership Congress in Las Vegas. August 2nd – 4th is the Governance Leadership Institute in Washington, DC. The ICCTA legislative priorities are 1) Community College Baccalaureate degrees; 2) preparing Illinois future workforce; 3) protection for the MAP grant recipients; 4) equity in higher education including neurodiversity; 5) equitable funding for community college operations and 6) to maintain local government control of community colleges. Trustee Broderick said House Bill HB1013 requires all public universities and community colleges to provide free child care. HB1133 allows community colleges districts to spend down its' working cash fund to zero. Senate Bill SB150 requires public universities and community colleges to adopt free speech policies.

5.4 Student Trustee Report

Student Trustee Stamborski gave his last report as Student Trustee. His report highlighted that Active Minds will have a picnic on April 27th where Dr. Namuo will also participate. Façade had their movie premier. The Collegiate Club Council will have a meeting on April 5th. The Blazer ran an article about Ramadan. Josh is currently participating in the fasting tradition of Ramadan. The ACCT SAC (student advisor committee) will have a meeting to modify bylaws and establish legacy documentation. Josh thanked all who participated in the Board of Trustees candidates forum on March 21st. Josh went to the ICCB-SAC meeting in Springfield. Trustee Morales said she was very proud of Josh and has watched him grow during this experience as Student Trustee. Trustee Broderick said she has been very impressed with all that he has done during his term. Trustee Mahalik said Josh has done a great and he has set the bar very high.

5.5 Building and Grounds Report

Trustee Mahalik reported that the Building and Grounds committee approved to update some classroom and public space seating. They also approved the CNA lab renovations at Romeoville campus. The G building switches are still waiting on parts and material to arrive. G building restrooms will be remodeled. Parking lot improvement are ongoing. The board room dais will start construction in June. The air handling unit replacement has been delayed. It will be 18 months until the equipment arrives.

5.6 Board Policy Committee Report

Trustee Morales gave the report stating there was nothing further to add other than what was previously reported.

Chairman O'Connell said that since this is his last regular meeting he wanted everyone to remember a few things. The position of Trustee is an apolitical position with a capital A. Trustees are here to service the college and the students and not here to run the college. We

hired the President to do that. Trustees have no right to tell the faculty and staff what to do. Trustee O'Connell said that Dr. Namuo and Dr. Farmer have technical knowledge and education backgrounds and the Trustees need to let them do their jobs. The trustees need to cut down on micromanagement. He then thanked the President and the administration for everything they do for JJC.
