# MINUTES OF THE REGULAR MEETING OF THE BOARD OF TRUSTEES OF ILLINOIS COMMUNITY COLLEGE DISTRICT 525 JOLIET JUNIOR COLLEGE

## 1. Call to Order/Roll Call/Welcome/Pledge of Allegiance

The Regular Meeting of the Board of Trustees of Joliet Junior College, Illinois Community College District #525, held in the Board Room at Joliet Junior College, 1215 Houbolt Road, Joliet, IL was called to order by Chairman Budzinski at 5:32 p.m. on Wednesday, May 21, 2025.

Trustees Present: Elaine Bottomley, Maureen Broderick, Jim Budzinski, Nancy Garcia Guillen, Diane Harris, Michelle Lee - virtual (arrived at 6:43 p.m. and left at 9:38 p.m.), Alicia Morales, and Student Trustee Brenton Bishop.

Karen Kissel led the Board in the Pledge of Allegiance.

#### 1.2 Communications

Dr. Namuo introduced Tanya Arias, an election analyst in partnership with the Will County Clerk's office, who spoke on how JJC can engage students to be involved with civic engagement opportunities. The Clerk's office has attended the JJC main street event where they helped with voter registration, explained the election process and the government work study program. Dr. Namuo also acknowledged Annette Parker, Will County Clerk for her support with this initiative.

## 1.7.1 Completion Report

Dr. Farmer recapped her experience in the Aspen Rising Presidential Fellowship program over the past year. The program focused on student success and completion which includes retention rate, graduation rate, equity framework, transfer rate and student completion with a purpose.

## 1.7.2 Tentative FY2025 – 2026 Budget Report

Karen Kissel, Vice President Finance and Administration, and Jeff Heap, Senior Director, Financial Services and Controller, gave the report. Karen reviewed the board's involvement in the budget timeline over the past year. Jeff reported was that this is the 53<sup>rd</sup> balanced budget for JJC with FY26 operating funds revenue and expenditures of \$122,222,000 of which 59% comes from property taxes. Salaries consist of 62% of the operating fund expenditures. This operating budget proposal represents a 4.66% increase over FY25's budget. This budget will be put on display for 30 days and voted on at the June meeting.

Kristi Mulvey, Executive Director, Institutional Advancement, supplied the board with a written report.

## 1.7.6 Building and Grounds Committee Report

Trustee Bottomley gave the report and said the committee discussed projects that are in design, projects in construction and projects wrapping up as well as projects that we can expect to see coming up in the future. She also said they touched briefly on the facilities master plan efforts.

# 1.7.7 Board Policy Committee Report

Trustee Harris reported that there was no meeting this month, so there is no report. There are four policies which will be voted on tonight as second reads.

# 1.7.8 Finance Committee Report

Trustee Morales reported one thing not covered in the budget report was that JJC will be changing the property, casualty and liability insurance carrier and transition to a consortium that other community colleges use.

# **1.7.9 Student Trustee Report**

Student Trustee Brenton Bishop acknowledged Dr. Amy Kuspa Sims, Chris Ulreich and Ryan Queeney for always being advocates for the student body and for helping him recognize the gravity of the student trustee role. Brenton reported on his attendance at Lobby Days where he met with state senators and representatives. He then highlighted the upcoming campus events and recent past campus events. He also acknowledged the winners of the Collegiate Club Council Recognition event and congratulated the graduating class of 2025.

# 1.7.10 President's Report

Dr. Namuo gave his report which included enrollment data as well as recent events around campus. He acknowledged Congresswoman Underwood for her contributions to the EBC program as well as State Representative Natalie Manley and State Senator Meg Cappel for their initiative to provide funds for test prep software for JJC students. He also announced a partnership with the Valley View Unified School District and their Step program which now host a coffee & pastry kiosk at the Romeoville campus. The Plainfield Step program also has a presence at the JJC main campus. He also reported that JJC hosted bring your kids to work day, a student and staff basketball game and a wheelchair basketball game with

Lincolnway Special Recreation Association this past month. Graduation had the largest class of 763 which also came with a brief power outage due to the sudden dust storm. Dr. Namuo attended the Grundy Economic Development Council Legislative Breakfast and visited Lockport High School to celebrate their district as having the highest enrollment in the JJC dual credit program. Kickoff of the facilities master plan has begun. Dr. Namuo, Student Trustee Bishop and Trustee Harris recently attended Lobby Days in Springfield where the team had meetings with multiple state leaders.

Celebrations of success included the JJC track and field team, softball and baseball teams. He also acknowledged the human resources department under Judy Connelly's leadership as Chief Human Resources Officer.

She reported on her attendance at Lobby Days in Springfield and she gave an update on the ICCTA awards which will be given out at the conference on June 6. Trustee Harris also gave an update for ACCT which included support for Congress to continue federal investments to community colleges, Pell grant programs, federal student loan & work study programs and TRIO.

# **5.2 Trustee Updates**

Trustee Bottomley said it is an honor to be and serve as a JJC Trustee. She said graduation is what reminds everyone why we are all here. She said the way trustees speak to each other matters and it is time to move forward and focus on the future. She said she is proud of the 763 graduates and all the financial connections JJC has provided to them. She would also like the trustees to continue to hold themselves accountable and to not lose track that the students are what is most important.

Trustee Harris said she took a tour of the Student Wellness center. She was impressed with the Zen Den. She also attended the Frankfort State of the Village and the Grundy Economic Development Legislative Breakfast. She also congratulated the newly elected trustee and the two reelected trustees and said she looks forward to a long and successful balance supporting the goals and the missions of the students.

Student Trustee Bishop said it is an honor to the student trustee. He said there is a survey on the campus' TVs related to HB 3717 which he encourages everyone to take. He thanked the students who have and continue to engage continually with the board. He said it's really important that trustees engage and to hold our representatives accountable.

Trustee Broderick said she had some recommendations for the board including to have the trustees review the agenda, all contracts, to provide all legal bills not redacted, to have the trustee travel budget be one-line item and not specific to trustee or event. She also asked to have all presidential monthly expenses sent to all trustees including the purpose and return of investment for each expense and she said all trustees are entitled to go to events.

Trustee Morales said the trustees are not entitled to anything except to come to meetings on time and to participate in the meetings and as far as travel, all trustees can participate in events and travel if they are in good standing. Trustee Morales thanked everyone for being patient with these long meetings. She also asked everyone to contact their legislators to support and advocate for federal funding for community colleges.

Chairman Budzinski said graduation was incredible and it takes everyone to make it happen for the students. He acknowledged Dr. Namuo's efforts and vision for the college. He said he appreciates the students who voice their opinion at these meetings as we can't get better as a college if we don't know what the students need or want. He thanked everyone involved in the budget process and he looks forward to success in the upcoming year.
