

Illinois Veterinary Medical Foundation 2020 Certified Veterinary Technician Scholarship Application

The Illinois Veterinary Medical Foundation is offering 5- \$500 scholarships to second year certified veterinary technician students. There will be one scholarship awarded per AVMA accredited CVT school in Illinois. The purpose of this scholarship is to engage the CVT student in organized veterinary medicine as critical team members.

Program Guidelines & Priorities:

- Applicants must be second year certified veterinary technician students in an Illinois AVMA accredited veterinary technician program and a member of the Illinois State Veterinary Medical Association. (Application can be found online at www.isvma.org)
- Scholarship funds will be paid **directly to the college**, not the student. The scholarship funds will be issued to the college or university upon receiving a certificate of enrollment for the fall semester, which includes the Student ID number and Financial Aid Office address.
- Applications must be received by the IVMF no later than June 30, 2020. Late applications will not be accepted.
- There will be requirements to be fulfilled after receipt of the scholarship that will be defined in the application below. Please review before signing the application.

The applications will be reviewed and recipients selected by the IVMF board of directors. The scholarships will be awarded no later than August 1, 2020.
