Questions Received:

1. I am assuming the black chef coats have plastic buttons, the same as the white?
Black chef coats can have plastic buttons or whatever is provided by the awarded vendor. These coats must be provided for sign language interpreters for hard of hearing students in Culinary Arts. These will only be required if there is an interpreter in class. This will not be necessary every semester.
2. There is a black tablecloth listed as item 21 that does not delineate the size of the cloth.

3. Item 22 lists a white apron, that, I assume is a bib apron?
Yes, item 22 refers to a bib apron.
4. Is there a particular reason you are specifying a yellow bag for the Renaissance Center?
Standard colored bags are acceptable.
5. Do you require ANY summer deliveries, or do you completely shut down?
 - a. ***Food Services will require one (1) delivery per week during the summer.***
 - b. ***Culinary Arts will require normal deliveries until 7/15/16 at which time no additional uniforms will be needed. The Culinary Arts Department will notify the awarded vendor to stop deliveries.***
 - c. ***Renaissance Center will require weekly deliveries through May 13, 2016 as this location is expected to close at that time.***
