LIC-CT8540-1A > Cisco 8540 Wireless Controller 1 AP Adder License
LIC-CT8540-DTLS-K9 > Cisco 8540 Wireless Controller DTLS License
CON-SNT-LICCT854 > SNTC-8x5xNBD Top Level SKU for 8540 AP Adder Licenses (12 months or 36 month as needed/appropriate)
CON-SNT-LICCT85C > SNTC-8x5xNBD Cisco 8540 Wireless Controller 1 AP Adder (12 months or 36 month as needed/appropriate)

I'm saying that because the top level part number is usually an indication that you will be 'adding' licenses to the existing wireless controllers. If you do not need to add licenses to the existing controllers, then that top level part number can be removed from your bid document.
