***Microsoft Gold Partner status is required in order for our vendor to have access to all resources and contacts at Microsoft in order to give us the support we need.***
2. I am looking at the Title III Grant Sharepoint Consultant Rebid. Under the SOW on page 11 it states that the Awarded Vendor must be a Microsoft Gold Partner, this was not in the original bid. We are a Microsoft VIP Partner, can we still bid on this?  
***Please see question #1.***
3. Who's the incumbent, and has their company been able to successfully meet the customer's requirements?  
***This information is not available.***
4. Will this work be done on site, or will the vendor be assisting remotely?  
***There will be both, work done on site and the vendor will be doing work remotely.***
5. May I ask quick question on 'The awarded vendor must be a Microsoft Gold Partner'. Will JJC allow us to bid with a partner (sub-contractor) that is Microsoft Gold Partner? Or do we (as the primary contractor) need to be a Microsoft Gold Partner?  
***We require the primary contractor to be the Microsoft Gold Partner, and do not prefer sub-contracting since subcontractors are not allowed domain administration access.***
