***L-MGMT3X-AP-K9, L-MGMT3X-PI-BASE, and R-PI38-SW-K9 are associated with serial #WMP250601DZ***
3. Would you please provide your organization's intended budget, as an addendum within the currently available posting for this solicitation? In your email notification yesterday below regarding the "Cisco Smartnet Renewal Rebid", you stated that "the bids received were over the current budget". As all of the bids were over your organization's intended budget, it is possible that your organization's budget falls below the standard industry price range for Cisco Smartnet. Thank you and have a nice day.  
***While the college does not share budget information during the bidding process, it is absolutely possible that our budget falls below standard industry price range. The purpose of the rebid is to see if we can get a larger number of responses so that we can accurately determine whether our budget needs to be adjusted.***
4. Serial WZP23350EEL reflects an inactive install base so it cannot be quoted. Please advise.  
***Serial WZP23350EEL is covered until 2024-10-23 but needs to be listed in smartnet contract. This item will be removed from the ESM pricing matrix.***

5. Please note SW Support (SWSS) is no longer available for the below Cisco ONE perpetual Licenses and they had to be removed from the quote as they are being replaced by DNA subscriptions. Product to be replaced with DNA C1F3UAIK9, C1FPCAT38501K9, C1APCAT38501K9
