This solution does not need to be compatible with Canvas. The RFP verbiage in the first paragraph on page 12, section a. Current Environment should read, "The College desires for the vendor to currently integrate seamlessly with Workday to offer, track and report on employee learning and training activities. Also addressed in question #6.

## **Questions Received:**

1. Hello, Who is the current vendor providing this service/contract? Thank you

Joliet Junior College does not currently have a vendor providing on-demand learning and development for all employees. The college's vendor for compliance training is Vector Solutions.

3. The proposal criteria is pretty robust. Is the expectation to include all the information on 1-2 pages max?

The only item specifically limited to 1-2 pages is the letter of transmittal, item III. C. in the RFP. Proposal length is at the discretion of the vendor.

4. What is the total expected number of users for this content?

The current number of users (employees) is approximately 1,200.

5. Is the audience size for highly technical content, such as Microsoft certifications, different from the total number of expected users? (not how to make a pivot table)

Yes, we estimate approximately 40 employees in the audience for the highly technical content, primarily these are employees of the IT, iCampus, and Tech faculty who might pursue Microsoft Certifications.

6. Is Canvas the only professional Learning Management System currently being utilized for JJC employees & staff members?

This solution <u>does not</u> need to be compatible with Canvas. The RFP verbiage in the first paragraph on page 12, section a. Current Environment should read, "The College desires for the vendor to currently integrate seamlessly with Workday to offer, track and report on employee learning and training activities.

7. You mentioned content needs to be compatible with Canvas. What is the preferred method for Canvas to 3rd party content? (i.e. AICC, SCORM, etc.)

8. Is there interest in content being consumed from a Cornerstone Content portal instead of Canvas? (this portal would not impact the cost)

The college desires for learning content to be available in other languages besides English. Additional languages are not required but strongly desired.

10. We possess an enterprise application, but the courses are integrated with other cloud-based partners. Will this be ok as a solution?

The college desires for the vendor to currently integrate seamlessly with Workday as this is the Learning Management System being utilized for JJC employees.

11. Requirement requires integrating with LMS like Canvas and Workday. What kind of integration is required, is it only SSO based or do we need to transfer status, score, etc. back to LMS?

Please see the response to question #6 above. This solution does <u>not</u> need to be compatible with Canvas.

Workday provides two link options to use with the Learning application of Workday: SAML single sign-on (SSO) links and quick links. Workday supports packaged e-learning content such as SCORM 1.2, SCORM 2004 (V2-V4), AICC HACP.
