

# CARES ACT INFORMATION

The CARES Act is federal legislation which provides a variety of financial support to individuals and businesses affected by the COVID-19 pandemic. The CARES Act established and funded the Higher Education Emergency Relief Fund (HEERF) to provide emergency financial aid grants. One part of this federal program allocates money to Joliet Junior College, and a portion of that allocation will be awarded to students who are experiencing expenses due to the disruption of campus operations due to coronavirus.

## **Total Amount of Funds Received**

The college's allocation through the HEERF program to be awarded to students is \$2,748,813.

## **Total Amount of Funds Distributed**

The total amount of Emergency Financial Aid Grants distributed to students under Section 18004(a)(1) of the CARES Act as of July 21, 2020 is \$458,400.

The amount of HEERF funding that institutions received is varied based on the Department of Education's allocation formula. That means the amount of the emergency grants at Joliet Junior College will not be the same as at other colleges. Each institution developed its own strategy for disbursing the funds to eligible students enrolled at their campus. These funds are limited, are not guaranteed, and requests may not be granted in full.

## **Eligible Students**

As of July 21, 2020, 1,673 JJC students were eligible to participate in this program. Eligible students for Summer 2020 participation were determined using the following criteria:

- 1) Enrolled in Summer 2020 courses
- 2) Have completed a 2019-2020 Free Application for Federal Student Aid (FAFSA)
- 3) Meet basic eligibility criteria for Federal Title IV Financial Aid can be considered for these funds. Student must:
  - Be enrolled or accepted for enrollment in a degree, certificate or other recognized educational credential;
  - Not be enrolled in elementary or secondary school;
  - Have a high school diploma or its recognized equivalent;
  - Be maintaining satisfactory academic progress (SAP);
  - Not owe an overpayment (refund) on Title IV grants;
  - Not be in default on a Title IV loan;
  - Be a U.S citizen or national, a permanent resident, or an eligible noncitizen ;
  - Have returned any fraudulently obtained Title IV funds, if the student is convicted of or pled guilty or no contest to charges;
  - Not have fraudulently received Title IV loans in excess of annual or aggregate limits;

- Have repaid any Title IV loan overpayment amounts in excess of annual or aggregate limits, if obtained inadvertently;
- If you are male, have registered for Selective Service;
- Have a valid SSN, except for residents of the Federated States of Micronesia, Republic of the Marshall Islands, or the Republic of Palau; and
- Not have a federal or state conviction for drug possession or sale, with certain time limitations.

### **Total Number of Students Receiving Grant**

The total number of students who have received an Emergency Financial Aid Grant to students under Section 18004(a)(1) of the CARES Act as of July 21, 2020 is 1,013.

### **Process to Determine Student Eligibility and Grant Amount**

JJC used the methods below to determine which students receive Emergency Financial Aid Grants and how much they would receive under Section 18004(a)(1) of the CARES Act.

#### **Participation and Eligibility**

Students apply online and indicate the amount of expenses they have incurred from the disruption of campus operations due to coronavirus. Enrollment and federal financial aid eligibility are verified. Students are notified by their JJC student email of their eligibility. If eligible, awards will be viewable through Financial Aid Self-Service. Funds will be issued by the Student Accounts & Payments Office.

#### **Determining Award Amount**

Students complete an online application and provide a signed statement describing the expenses incurred from the disruption of campus operations due to coronavirus to substantiate their funding request. Documentation of the expense(s) may be requested for verification. Maximum awards are \$1,400.
